The Board attended the LEPC Meeting at noon.

The meeting was opened to public participation at 1:00 p.m.

The Board of Commissioners of McCone County, Montana, met in regular session with Lonny Jensen, Ty Taylor, and Alan Stempel present. Presiding Officer Lonny Jensen called the meeting to order. The pledge of allegiance was recited. Commissioner Taylor moved to approve the agenda. The Board approved the December 8, 2025 Minutes as amended.

The Board reviewed the Type I Zoning Request for the Mount Antelope area with updates of status on the deeds involved and County Attorney information.

The Board tabled the decision to appoint a new member to the Missouri River Board.

Keri Taylor, DES Coordinator, met with the Board to discuss a personnel issue, and a grant application to the Montana Resiliency Fund. Commissioner Stempel moved to approve the grant application. Commissioner Jensen seconded the motion and the motion passed 2-0. Commissioner Taylor abstained from the conversation. **(A copy of the grant details are on file in the Commissioners' files.)**

The Board reviewed and approved the Year End Financial Report for the FAA.

The Board reviewed the Stordahl Encroachment Permit. Commissioner Stempel moved to conditionally approve the Encroachment Permit after the North Road Foreman approves of the permit. Commissioner Taylor seconded the motion and the motion passed 3-0. **(A copy of the Encroachment Permit is on file in the Commissioners' files.)**

The Board reviewed Voucher # 1020. Commissioner Stempel moved to approve the voucher. Commissioner Taylor seconded the motion and the motion passed 3-0. **(A copy of the voucher is on file in the Commissioners' files.)**

Savannah Hanson, Clerk of Court, Paul Skyberg, Sheriff, Nancy Stempel, GIS Coordinator, and Christin Patterson, Treasurer Secretary, met with the Board to discuss acquiring a Verkada Security System for the Courthouse.

Paul Skyberg, Sheriff, met with the Board to discuss Law Enforcement issues.

Nita Crockett, Treasurer, met with the Board to present the updated Cash Reconciliation and Investment Report for November 2025. Commissioner Stempel moved to approve the report and Commissioner Taylor seconded. The motion passed 3-0. **(A copy of the report is on file in the Commissioners' files.)**
